Membership Rates

There are two types of accreditations:

Standalone accreditation

Supportive accreditation

Stand-alone accreditation can only be issued to recognized or approved schools. Schools that are recognized or approved by their state department of education in the US or countries outside of the US.

Supportive accreditation can be issued only to schools that are not yet recognized by the state of their country. They can receive accreditation status through an accredited school in good standing.

INSTITUTIONAL ANNUAL MEMBERSHIP PER LEVEL

National Transregional Accrediting Council (NTAAC) focuses on the following three levels:

1. [] Freshman Status – A Freshman institution is in the process of developing its facility, curriculum, staff; policies, etc. Their institutional/educational program has been operating for less than twelve months. An annual report is required. Proof of recognition from the Department of Education is required. First Year Fees \$1,200.00

2. Sophomore Status – An institution with a sophomore status has applied for accreditation to the Board of Directors of NTAAC, and is in the process of completing its self-study. They have been in existence for at least twelve months. An annual report from the Department of Education is required. The second year's Fee is \$1,400.00.
3. Junior Status – An institution with a junior status has satisfactorily met all previous NTAAC status of accreditation standards and has been awarded its accreditation certificate for up to two years. An annual report from the department of education is required. The Third year Fees is \$,1600.00.
4. Senior Status – An institution with senior status has satisfactorily met all previous three levels of NTAAC accreditation standards and has been awarded their accreditation certificate for up to three years and it is being granted the fourth year. An annual report from the department of education is required. The Fourth year Fee is \$1,900.00.
5. Graduate Status – An institution with a graduate status has satisfactorily accredited for 4-5 years and has met all NTAAC standards and is awarded a five years certificate of accreditation. An annual report from the department of education is required. Five years term Certificate Fee is \$3,900.00. With this option, the accreditation certificate will be due to renew in 5 years.
6. Executive Status-An institution with an executive status that has satisfactorily accredited for up to 10 years and has met all NTAAC standards is awarded all the previous levels and applies the 10 years certificate of accreditation. An annual report from the department of education is required. Ten years term Certificate Fee is \$5,900.00. With this option, the accreditation certificate will be due to renew in 10 years.

FOR FUTURE REPORTING

The followings are sustainers' fees and are to be paid annually or semi-annually. This fee is charged per enrolled student and a currently active student's roster must be submitted with the fees before graduation.

The sustainer's fees are due quarterly (every three months)
